



MEMORANDUM OF UNDERSTANDING BETWEEN PRINCONSER UNIVERSITY S.A.C. AND GUAL PERIOK FOUNDATION UNDER THE NAME OF “SOUTH AMERICAN-ASIAN BRIDGES FOR PEACE”

FIRST: PARTIES INVOLVED

This Memorandum of Understanding (MoU) is entered into by Princonser University S.A.C., Registry Number: 15502330, Tax ID Number: 20611994541, with its registered office at CAL. GERMAN SCHREIBER 276, San Isidro, Lima, Peru, hereinafter referred to as "Princonser University," and Yayasan Gual Periok, Co. No. 708824-U, with its registered/business address at 24B, Jalan SG 1/2 Taman Sri Gombak 68100 Batu Caves, Selangor, Malaysia, hereinafter referred to as "YGP". Both entities, hereinafter collectively referred to as "the Parties," agree to establish a collaboration and understanding under the terms set forth below.

SECOND: PURPOSE OF THE MoU

The purpose of this Memorandum of Understanding (MoU) is to formalize a strategic collaboration between the parties to advance the principles of peace, humanity, and philosophical inquiry, with the following shared objectives;

1. To collaboratively develop and implement the Princonser method across Asia, adhering to the ideals of universal wisdom, peace, and sustainable development.
2. To jointly promote and disseminate Al Quranic Philosophy in South America, in alignment with the principles of global wisdom, harmony, and sustainable growth.
3. To foster peace through civic education initiatives rooted in the values of reason, morality, responsibility, justice, and enlightened thought.
4. To promote peacebuilding, reconciliation, socio-economic progress, and international cooperation through targeted societal and human development programs.

THIRD: AREAS OF COLLABORATION

The Parties agree to cooperate in the following areas:

1. **Research and Development:** Implementation of scientific research projects applicable to civic education, health, and humanities.
2. **Training and Education:** Development of training programs, courses, and seminars on topics of mutual interest.
3. **Cultural and Knowledge Exchange:** Conducting activities that promote cultural exchange and mutual understanding between Peru and Malaysia.
4. **Forums and Conferences:** Organization of forums, conferences, and similar events to showcase and disseminate the initiatives and achievements of both Parties.
5. **Societal and Human Development Programs:** Implementation of projects aimed at advancing societal growth and human development in both Peru and Malaysia.



FOURTH: RESPONSIBILITIES OF THE PARTIES

Both Parties shall undertake the following responsibilities:

1. **Provision of Expertise and Human Resources:** Supply the requisite knowledge and skilled personnel to support the execution of activities outlined in the third clause of this MoU.
2. **Logistical Support:** Facilitate logistical resources essential for the implementation of projects within Malaysia and Peru.

FIFTH: PLANNING AND MONITORING

The Parties will establish a coordination committee that will meet periodically to supervise the progress of the ongoing activities or projects to ensure the fulfillment of objectives, and propose adjustments to activities if necessary.

SIXTH: DURATION OF THE MoU

This MoU shall be effective upon the date of signing and shall have a duration of **two (2) years**, renewable by mutual written consent of the Parties

SEVENTH: AMENDMENTS AND TERMINATION

Any amendments, modification or additional provision to this MoU must be mutually agreed upon in writing by both Parties. Either Party may terminate this MoU by providing written notice three (3) months in advance.

EIGHTH: DISPUTE RESOLUTION

In the event of any dispute arising out of or in connection with this MoU, the Parties will attempt to resolve the matter through amicable negotiations.

NINTH: DELEGATION OF RIGHTS AND OBLIGATION

Neither Party has the right to delegate its rights nor obligations under this MoU to a third party without written consent of the other Party.

TENTH: FINANCIAL OBLIGATIONS

This MoU does not create or impose any financial obligation on either Party. Nothing in this MoU shall be construed as a commitment to provide funding or reimbursement to the other Party. Any future financial commitments shall be subject to separate negotiations and agreements.



ELEVENTH: FINAL PROVISIONS

1. **Independent Relationship:** This MoU does not create any partnership, joint venture, or employment relationship between the Parties, and neither Party shall act as an agent for the other. Each Party shall remain independent and responsible for its own actions, obligations, and liabilities.
2. **Confidentiality:** Both Parties agree to respect and protect the confidentiality of any proprietary or sensitive information shared during the collaboration.


